ORDER:

Under Rule 10 (a) of Telangana State and Subordinate Service Rules, 1996, read with the orders / instructions issued in the references cited, the following teachers of Class-II of T.G.E.S of Government Management Schools are hereby promoted to the post of School Assistants & Head Master of Primary School (LFL) at Government Management Schools in the vacancy noted against their names as per their preference of options exercised during the web counselling as per seniority and as per the annexure appended to these proceedings.

They are requested to join on relief in the new promotion post within stipulated time as per Rule 11 (b) of Telangana State and Subordinate Service Rules, 1996.

The promotion orders now issued are subject to the condition that his / her seniority is subject to outcome of the SLP No. 1819-1821/2019 orders dated 04.02.2019 pending in the Hon'ble Supreme Court of India, New Delhi on Unified Teachers' Service Rules. The promotion orders are also subject to outcome of the orders of the Hon'ble High Court in W.P No.s 26915/2023 and 12410/2024.


He / She shall abide by the terms and conditions as stipulated by the Government and is liable for any action deemed fit for violation thereof.

The dates of relieve and joining should be reported promptly.

They are not entitled for TTA and joining time as the postings are ordered as per their choice.
